

## **Agenda for circulation to Senate members**

In view of the current COVID19 pandemic situation the following agenda points were discussed through an online meeting held on 21 April 2021 at 12.00 Noon with the Registrar, Deans, Heads, Chief Warden and Asst. Registrars, and the concurrence of the members has been obtained and are placed before the Senate for their consideration and approval.

### **Agenda Item 1: Fee Structure for the Academic year 2021-22**

Each year the Fee structure for the first year batch of UG, PG and Ph.D. programmes are revised with an increase of 15% as per the decision of the BoG. However, the fee of 15% increase was not implemented in the academic year 2020-21 due to the covid'19 pandemic and the same was ratified by Senate as per Item # 8.9 of the Minutes of the Eighth Senate Meeting. After detailed deliberations, it is suggested not to implement the 15% increase in the Fee Structure for the forthcoming Academic year 2021-22 also considering the due to the severity of the second wave of the pandemic.

It has also been suggested that the Hostel Seat Rent component (Rs.10,000/-) of the Institute fees in the present fee structure shall be shifted to the Hostel Fees and based on the availability of the seat in the hostel, the Day scholar's shall be charged the Hostel Seat Rent component. The above agenda item is placed as Enclosure -I for consideration and approval of the Senate.

### **Agenda Item 2: Hostel Seat Rent for the Academic year 2020-21**

As per the ratification of the Senate, the Hostel Seat Rent of Rs.10,000/- and Sports/Games Fees of Rs.1,000/- in the fee structure for the Academic Year 2020-21, has been deferred till the time of Physical Reporting of the students (Enclosure-II). With the prevailing pandemic situation, the students may not be in a position to physically report at the Institute till June 2021 (end of even semester of A.Y- 2020-21). However, the hostel & mess maintenance and establishment charges of Rs.3000/- has been charged from the students.

In view of the above and the representations from the students, it is proposed to waive the Hostel seat rent as a one-time measure for the academic year 2020-21, considering the pandemic situation and the same is placed before the Senate for consideration and approval.

All the esteemed Senate Members are requested to share their views and concurrence on the above Agenda items at the earliest.
