Relevant documentary evidence in this regard shall be uploaded along with the

3. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

1. Declaration by the bidder that he /she has not been blacklisted by the Departments/Ministries of the Govt. of India/State Govt./PSUs in company letterhead in latest date. (Attested copy has to be submitted along with the bid documents).
2. At the time of deploying manpower, the Contractor shall strictly comply with all the applicable labour laws /Acts norms including but not restricted to the age of the workers, conditions of employment and shall also ensure that a police verification and security check for all the personnel engaged Any default in complying with the same or any misrepresentation regarding compliance of the same shall entitle SPA Vijayawada to initiate appropriate civil or criminal proceedings regarding the same.
3. The Contractor shall not employ any person of age below 21 years and above the age of 50 years and the persons so engaged shall be sound in health capable of performing their work as per instructions and should not be suffering from any illness, infection and disease.
4. The Contractor shall issue necessary identity cards to its personnel and shall keep and maintain a complete record of all the personnel who are or who shall be assigned any work at the in pursuance of this contract.
5. The firm should ensure that the drivers employed are well behaved, reasonably educated, and having communication skills in Telugu and Hindi/English, and conversant with traffic rules/regulations and city roads/routes as well as security instructions.
6. The drivers must also observe all the etiquette, protocol and extend usual courtesy (like carrying office bags/files to the concerned chambers, etc.) while performing the duty.
7. Contractor shall indemnify SPA Vijayawada from any liabilities arising out of the employment of the manpower.

8. The personnel deployed by the Contractor shall be smartly dressed in neat and clean having Identity Card containing Photo, Name, Address & date of birth and professional valid driving license.
9. The personnel engaged should be of robust physique and project an image of utmost discipline. They have to be extremely courteous with pleasant mannerism in dealing with the public/officers/VIPs. SPA Vijayawada shall have right to remove any person in case the personnel is not performing the job satisfactorily. The Contractor shall have to arrange the suitable replacement in all such cases.
10. The Contractor shall bear the cost and responsibility of providing statutory labour provisions of ESI, EPF, insurance, Identity Cards, valid driving license, valid pollution token, uniform, and any other document/equipment as required for discharge of the duty of his staff, stationery for writing duty charts and registers for records keeping as per requirements.
11. SPA Vijayawada shall not provide residential accommodation to any of the personnel/ employee of the Contractor.
12. The tenderer may be a proprietary firm, Partnership firm, Limited Company, Corporate body legally constituted engaged in car services, who should have required licenses issued by Regional Transport Authority (attested copy has to be attached).
13. The Contractor shall also obtain and keep in place necessary insurance policies, Medclaim policies, group insurance schemes of adequate value to cover his personnel, employees with regard to any accidents, injury or the liability under the Employee Compensation Act.
14. No change of driver(s) will be allowed normally without the prior permission of Vehicle -In-charge or SPAV authorities.
15. The bidder should submit a performance certificate from his previous/existing employers including SPAV where he has deployed the service. The letter should clearly mention that their services are Satisfactory/Very Good. **(Mandatory)**
16. Duration of the service contract may be extended up to 1 year beyond the initial contract duration (subject to satisfactory performance and mutual consent).
17. For outstation night charges -Service provider will be paid Maximum of Rs. 1000- per night if duty hours end between 11 pm and 6 am at an outstation location (away from HQ).

3. **Generic**

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. **Service & Support**

6. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

7. **Past Project Experience**

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the

invoices have been executed.b. Execution certificate by client with contract value.c. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
